#### PRIMARY GRADES WORLD LANGUAGE

C. Sturm moved, T. Lerner seconded, and the Board voted 4-0 to table the following motions until the Special Board of Education to be held on January 11<sup>th</sup>, 2017- to discontinue grades K-1 world language for the remainder of the 2016-2017 school year due to a dearth of certified/qualified candidates and to discontinue world language in grades K-2 for the 2017-2018 academic year in order to provide instructional time to meet the rigors of new science and social studies standards.

#### **PROGRAM OF STUDIES**

C. Sturm moved, T. Lerner seconded, and after discussion with Principal Marc Balanda, the Board voted 4-0 to approve the revisions to the BHS Program of Studies as recommended by the CAPE subcommittee.
