SUPERINTENDENT'S UPDATE

The Superintendent gave a brief calendar update that has been impacted by the weather. He said as of tonight, the district has closed for 5 school days, we have experienced 9 delayed openings and 1 early dismissal.

If other closures occur, our projected but tentative last day of school will be Wednesday, June 17th. Any further closings will be added to June 17th.

He is still reviewing potential options with regards to CES missing the one instructional day.

He explained that Center School was closed due to a water issue on 2/17. A cold-water pipe coupling burst causing water to flood the cafeteria. This problem was compounded by a clogged kitchen floor drain.

Facilities Supervisor Tom Tibolla and Maintenance Mechanic Dan Caldwell and the Center School custodial staff did a great job in containing and minimizing the problem.

Mr. Iassogna thanked Principal Krys Salon and her staff and students as well as ServPro, Town Sanitation Department, Fire Marshall and Insurance Adjuster. This problem will be covered by our insurance after our deductible is met. He said the following needs to be done-

Removal and installation of new floor tile in the Kitchen Cafeteria and Hall area; and sheet rock and molding replacement for damaged areas. He also said to be assured that all areas are compliant with Health and Building codes and regulations, particularly with regard to mold and asbestos and that student and staff safety has been confirmed by the on-site officials.
