SUPERINTENDENT'S UPDATE

Superintendent Barile thanked Genie Slone for her 25 years of service to Brookfield and welcomed Dr. Maureen Ruby as the new Assistant Superintendent. He gave an update on the current enrollment at Center School. Mr. Barile welcomed Cyndi Adamski as the Interim Athletic Coordinator as the district interviews for a permanent one.
