SUPERINTENDENT'S RECOMMENDED 2014-2015 BUDGET

The Board and Superintendent continued their discussion on the 2014-2015 budget. Among discussing several line items, they discussed the insurance rate going up 20% and talked about going out to bid. The Board also agreed to change the school calendar from 182 days to 180 days. Additionally, they agreed to increase the amount of pay to participate from \$125 to \$175.

BOARD OF EDUCATION ADOPTION OF THE 2014-2015 BUDGET

After discussion, <u>S. Queenan moved</u>, <u>P. Checco seconded</u>, and the Board voted 4-2 that the Board of Education adopt its 2014-2015 budget in the amount of 40,080,470 or 4.66%.
