SUPERINTENDENT'S UPDATE

Dr. Barile began his update with a presentation by Dr. Mahon regarding the K-3 Reading Legislation-Program update. The Superintendent gave an update on the burst pipe at BHS on Christmas Day. Dr. Barile talked about the "Note from your School Nurse" school message that went to families and gave an update on the Special Education Program Review. A brief video was shown regarding the progression of the WMS wall repair.

SUBCOMMITTEE REPORTS

Finance- 12/12/2022- Mrs. Fernandes said the subcommittee discussed check registers, the November, 2022 financial report and the Superintendent's proposed 2023-2024 operating budget.

Special Finance- 12/19/2022- Mrs. Fernandes said the subcommittee reviewed and discussed questions that were asked regarding the Superintendent's proposed 2023-2024 operating budget.

Policy/Communications- 12/21/2022- Mrs. Brooks said the subcommittee welcomed Sharon Butow as its newest subcommittee member (she is replacing Mike Murphy who will now be on the Equity & Inclusion committee). The subcommittee discussed Policy#5118.111, Non Resident tuition and will bring recommendations to the full Board at its February 15th meeting. Policy#5125, FERPA, Policy#5144.1, Restraint & Seclusion, and Policy #5131.911, Bullying are in the hands of the attorney and will be brought to

the full Board for a first reading on February 15th. Discussion continued on Policy #6162.51, Survey of Students. This policy will be brought to the full Board at its January 4th meeting. Communications discussion included the webpage, videos celebrating the schools and the budget forum.

NEW POLICY # 6115, CEREMONIES & OBSERVANCES-SEPARATION OF CHURCH AND STATE

A. Foster moved, R. Fernandes seconded, and the Board voted 7-0 to approve new Policy # 6115, Ceremonies & Observances Separation of Church and State, for a final reading as recommended by the Policy/Communications subcommittee. First reading was on November 16, 2022.

NEW POLICY #6162.51, SURVEY OF STUDENTS

A. Foster moved, R. Fernandes seconded to approve new Policy #6162.52, Survey of Students, for a final reading as recommended by the Policy/Communications subcommittee. First reading was on November 16, 2022 with further discussion at the December 14, 2022 Board meeting.
