SUBCOMMITTEE REPORTS

Facilities- 3/1/2023 & Special Facilities- 3/9/2023- Mrs. Greenstein said the subcommittee discussed the School Dude reports and received an update on all active capital projects from Mr. Caldwell and Mr. Post, as well as the scope of work for the building condition study. Miscellaneous discussion included the condition of the walls at BHS after the lockers were removed and Mr. Caldwell accompanied Selectman Shaker on a tour of Center school. The brief discussion at the meeting on 3/9/2023 focused on the BHS Guidance wing roof replacement.

CAPE-3/8/2023- Dr. Murphy said BHS STEM Director Andrew Hill presented a textbook for approval by CAPE and the full Board. Dr. Mahon engaged the subcommittee in an Impact of Strategic Plan discussion and led the subcommittee in a Strategic Plan exercise. Dr. Mahon also gave a follow up on the DESSA Assessment program.

Special Finance - 3/9/2023- Mrs. Fernandes said the subcommittee continued discussion on the 2023-2024 budget and funding for capital projects.

NEW BUSINESS

HEALTHY FOOD OPTION CERTIFICATION

A. Foster moved, R. Fernandes seconded, and the Board voted 6-0 that, pursuant to C.G.S. Section 10-215f, the Brookfield Board of Education certifies that all food items offered for sale to students in the schools under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards during the period of July 1, 2023, through June 30, 2024. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to school stores, vending machines, school cafeterias, culinary programs, and any fundraising activities on school premises sponsored by the school or non-school organizations and groups.

HEALTHY FOOD-FOOD & BEVERAGE EXEMPTION

A. Foster moved, R. Fernandes seconded, and the Board voted 6-0 that the Brookfield Board of Education will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards and beverages not listed in Section 10-221q of the Connecticut General Statutes provided that the following conditions are met: 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the food and beverage items are not sold from a vending machine or school store. An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held and must be the same place as the food and beverage sales.

A. Foster moved, R. Fernandes seconded, and the Board voted 6-0 to approve to replace Brookfield's existing Policy #5131.911- Bullying with CABE's version and approve Regulation#5131.911, Bullying, for a first reading as recommended by the Policy/Communications subcommittee.

POLICY #5144.1- RESTRAINT & SECLUSION

A Foster moved, R. Fernandes seconded, and the Board voted 6-0 to approve the deletion of current Policy #5144.1 -Restraint and Seclusion and accept an updated version based on language adopted by Wallingford Public Schools and approve Regulation, for a first reading as recommended by the Policy/Communications subcommittee.

BHS GUIDANCE WING ROOF AND MAINTENANCE VEHICLE REQUEST FOR FUNDING

A. Foster moved, R. Fernandes seconded, and the Board voted 6-0 that the Board of Education request the Board of Selectmen and Board of Finance allocate additional funds for previously approved capital projects in the amounts of \$142,200 for the Brookfield High School Guidance Wing Roof Replacement and \$15,313 for the purchase of a Maintenance vehicle.
