New Business:

22-23 Financial update: Mr. Post reported to the committee known or probable positive and negative variances. Negative variances totaling \$869,000 include Heating Oil, Diesel Fuel, Special Education Tuition, Special Education Transportation, Teacher Turnover savings, and Health Insurance costs. Positive variances of \$350,000 include Administrator Turnover savings, Director of Instruction salary, Special Education Extended School Year program, and the Bilingual Teacher. With input from Mrs. Marien and Mrs. Koch, the committee discussed Town contingency funds and the need to meet with other Town Boards to discuss the issue. The committee also asked Dr. Barile to contact his administrative team to identify areas where they can achieve savings.

23-24 Budget calendar: The committee reviewed the draft budget calendar proposed by Mr. Post and agreed to bring it to the full Board for approval. The committee discussed the need to include the Candlewood Lake Elementary School transition, security costs, ARP ESSER transition, and the impact of the healthy start times on the 2023-2024 operating budget in their discussions.

EFS: Dr. Barile reported that Mr. Post had successfully completed the year-end financial report (EFS) to the State.

Audit: Mrs. Marien gave the committee an update on the status of the 2021-2022 financial audit.
