<u>CALL TO ORDER</u> – Colette Sturm called the BOE meeting to order and Paul Checco called the MBC meeting to order at 7:05 p.m.

The public forum began with a presentation by personnel from Tecton Architects summarizing the format of the Forum to include a 30 minute presentation on the school building site to include Q & A after and also discussion and Q & A of the Eriksen Farm parcel. Agenda items include recent activities (refinements to the program, site design/due diligence and engineering coordination), previous designs for building/site, current design (overall and detailed floorplans, site plans, safety & security, building massing, exterior, materials and interior environment), student welfare (sustainability) and summarize next steps.

After the presentation from Tecton Architects and Consulting Engineering Services, the following Brookfield residents spoke and questions were addressed:

Marie Wilkins- 56 Flax Hill Road – Ms. Wilkins asked questions about energy use.

**Henry Pietras- 19 Rocky Road** – Mr. Pietras asked about the building materials being waste free and will those certificates be on file and available for review. How secure is the back of the building? Mr. Pietras asked about energy solutions.

**Bill Doyle- 17 Powderhorn Hill Road-** Mr. Doyle asked about ease of success, playgrounds, space for staff and elevators

Bob Belden- 7 Red Barn Lane – Mr. Belden asked about elevations and the parking lot during the transition.

**Debbie Brooks- 21 Crestview Drive**– Mrs. Brooks asked about the multipurpose room and the access to it. She asked if the cafeteria would double as a multipurpose room and providing more parking.

Bob Belden- 7 Red Barn Lane – Mr. Belden asked about the ballfields.

**Mark Engengro- 11 Rajcula Farm Road** – Mr. Engengro asked about the life expectancy of the design, i.e. window walls and inquired about what happened with the FEMA and flood plan. He asked not to go too abstract with the designs.

Mr. Pietras made additional comments regarding future proofing and free greening.

Discussion began on the Eriksen parcel.

**Diane Sivo- 13 Nabby Road**—Ms. Sivo asked Mr. Dunn for the opinion letter from the bonding counsel and the town attorney regarding Eriksen and she asked about an endangered species survey.

Mr. Blick asked additional questions regarding the revised site design.

Mark Engengro asked what is the timeline regarding the posting of the priority list from the State

Mr. Apgar- 8 Belden Hill Road-- Mr. Apgar asked if Eriksen Farm becomes off limits during school hours.

Willie Johnson- 78 Candlewood Lake Road- Mr. Johnson asked about the deed for the open space and the parking spaces.

Bob Marx- 11 Belden Hill Road- Mr. Marx asked if school children use site.

Shawn Schep-1 Belden Hill Road- Ms. Schep asked if other places are being looked at t build the fields.
