#### POLICY

#### Continue discussion of New Policy #6163.32, Service Animals

Dr. Sipala addressed regarding the Service animal policy which included discussion about the "handler" and the difference between service animals and therapy animals. Dr. Sipala will gather more information regarding the handler and will bring it back to the subcommittee.

## Continue discussion of Policy# 3171.1 Non-Lapsing Education Fund

Dr. Barile talked about the highlighted language regarding the non-lapsing policy. The district currently does not have this policy in place. After discussion to make some minor language changes, R. Fernandes moved, D. Brooks seconded, and the subcommittee voted unanimously to bring this policy to the full Board for a first reading.

#### Discussion of Policy# 3516, Safety

Mr. Post gave a brief overview of the Safety policy. His recommendation is to delete the current policy and adopt CABE's version. The language regarding school security and safety committee is more defined in the CABE version. After discussion, <u>R. Fernandes moved</u>, <u>D. Brooks seconded</u>, and the subcommittee voted unanimously to bring this policy to the full Board for a first reading.

## Discussion of Policy# 3532, Insurance

Mr. Post discussed adding one sentence from the CABE version to the existing version of this policy. He is checking on what the percentage of replacement costs should be and will report back to the subcommittee.
