2021-22 SFA - FSMC Contract Renewal Amendment

(Fixed Fees)

As authorized by section 2202(a) of the Families First Coronavirus Response Act (the Act)(P.L. 116-127) and extended by Food and Nutrition Services, both parties op in to the waiver:

7(CFR 210.16(d) and 7 CFR 225.6(h)(7) to permit school food authorities and summer food service program sponsors to extend existing food service management company contracts that would not otherwise be eligible for extension through SY 2021-22 or June 30, 2022.

This renewal amendment is between <u>BROOKFIELD PUBLIC SCHOOLS</u> (SFA) and the <u>WHITSONS SCHOOL NUTRITION CORP.</u> (FSMC) and constitutes Amendment No.<u>5</u>.

WITNESSETH:

WHEREAS, the parties entered into a certain Food Service Management Agreement, dated <u>July 1, 2016</u>, as amended by Addendum No. 1 dated <u>May 3, 2017</u>; Addendum No. 2 dated <u>April 26, 2018</u>; Addendum No. 3 dated <u>June 25, 2019</u>; and Addendum No. 4 dated <u>June 21, 2020</u> (collectively, the "Agreement") whereby, the FSMC manages and operates the SFA's USDA Child Nutrition food service program in <u>Brookfield</u>, CT; and

WHEREAS, the parties now desire to amend the aforesaid agreement;

NOW, THEREFORE, in consideration of the promises herein contained and for other good and valuable consideration, the parties hereto agree as follows:

- 1. Both parties mutually agree to extend the Agreement beginning July 1, 2021 and ending June 30, 2022, unless terminated by either party as hereinafter provided. (Section 16.1)
- 2. This agreement may not be further extended unless the USDA waives the requirement in 7 CFR 210.16(d) and 7 CFR 225.6(h)(7) for SY 2022-23. (Section 16.1 B)
- 3. Any and all references to the "2020-21" school year shall be amended to read "2021-22"
- 4. Section 12.11 (C) shall be amended to read "The FSMC's Management Fee (FSMC's profit) for August/September June is: \$1,759.13 per month for ten (10) months. Fee Total: \$17,591.29 (Per calculation below based on the agreed upon percentage not to exceed the March 2021 Consumer Price Index (CPI) Food Away From Home, Northeast Urban 4.5%)".

Fee Total: \$41,856.44 (Per calculation below based on the agreed upon percentage not to exceed the March 2021 Consumer Price Index (CPI) – Food Away From Home, Northeast Urban 4.5%)".

- 6. Additional changes (must be reviewed for material changes to the contract)

Section 12.11, Subsection K (Guarantee), of Article XII of the Contract shall remain the same at the amount of \$15,338.00 for the school year 2021-2022.

This renewal amendment is effective July 1, 2021, provided both parties execute this renewal by June 30, 2021. If this renewal amendment is executed after June 30, 2021, the effective date will be the date this document is fully executed.
