## Health 9 and Health 11 Curriculum:

There was a presentation of Health 9 and Health 11 curriculum by Mr. Steve Baldwin, Director of Athletics, Health & PE, K-12. Mr. Baldwin gave an overview of the state's new requirements for health education as has been previously covered in this committee. Mr. Alessio then described the units of study and the content, speaking to the depth that the new curriculum credits will allow instructors to go into with students in the new curriculum model. While there are some additions to the content, the real change is on the depth to which the content can be explore. The key focus of the health curriculum is supporting students to know themselves, understand how to live a healthy life style and develop of positive sense of self that will guide their personal decision making and interpersonal relationships. The CAPE Committee voted unanimously to recommend that the Board approve adoption of the Grade 9 and 11 Health Curriculum.

## Human Geography Academic Curriculum

Ms. Spencer, Curriculum Specialist for Humanities 9-12 gave a presentation on the new Human Geography course. She explained how the curriculum development design was planned and how the curriculum is being developed in our digital curriculum platform Atlas Rubicon.

Ms. Spencer shared that the book currently being used in AP and Honors Human Geography (The Cultural Landscape: An Introduction to Human Geography, AP Edition by Rubinstein; Pearson) has a new edition that was released in April 2019. The new edition will be purchased. This does not need approval as it is an update.

For the Academic Human Geography course (new course), Ms. Spencer is recommending Board adoption of the text Contemporary Human Geography by Rubinstein; Pearson.

The CAPE Committee voted unanimously to recommend that the Board approve adoption of the Academic Human Geography textbook Contemporary Human Geography by Rubinstein; Pearson. See attached documents

## Spanish Text Book Recommendation

Ms. Kemen Holley, WL and ESL Curriculum Specialist, K-12 presented on areas of development and current "hurdles" in the current Spanish programming.
