2019-20 SFA - FSMC Contract Renewal Amendment

(CPI-Food Away From Home, Northeast Urban)

This renewal amendment is between BROOKFIELD PUBLIC SCHOOLS (SFA) and WHITSONS SCHOOL NUTRITION CORP. (FSMC) and constitutes Amendment No. 3.

WITNESSETH:

WHEREAS, the parties entered into a certain Food Service Management Agreement, dated July 1, 2016 as amended by Addendum No. 1 dated May 3, 2017 and Addendum No. 2 dated April 26, 2018 (collectively, the "Agreement") whereby, the FSMC manages and operates the SFA's USDA Child Nutrition food service program in Brookfield, CT; and

WHEREAS, the parties now desire to amend the aforesaid agreement;

NOW, THEREFORE, in consideration of the promises herein contained and for other good and valuable consideration, the parties hereto agree as follows:

- 1. Both parties mutually agree to extend the Agreement beginning July 1, 2019 and ending June 30, 2020, unless terminated by either party as hereinafter provided. (Section 16.1)
- 2. This agreement may be further amended for up to one (1) one-year renewal(s) with mutual agreement. (Section 16.1 B)
- 3. Any and all references to the "2018-19" school year shall be amended to read "2019-20"
- 4. Section 12.11 (C) shall be amended to read "The FSMC's Management Fee (FSMC's profit) for August/September June is: \$1,654.93 per month for ten (10) months. Fee Total: \$16,549.34 (Per calculation below based on the agreed upon percentage not to exceed the March 2019 Consumer Price Index (CPI) Food Away From Home, Northeast Urban 3.0%)".
