Connecticut Next Gen Accountability Results

- Chronic absenteeism more than double pre-pandemic levels
- Percent 9th graders on track to graduate decreased more than 5%
 - Number of credits needed to be on track increased from 5 to 6
- Percentage of students enrolling in college within one year after high school graduation declined significantly
- Percent of students meeting Health Fitness in all areas decreased more than 7%
- Percentage of growth achieved in ELA and Math increased
- Post secondary preparation increased
 - Results include ECE Courses



What are we doing to address the areas of concern?

- Primary focus on addressing learning loss of students at all levels
 - Use and review of interim assessment blocks at WMS
 - Review of student data as a means of addressing gaps throughout 22-23
- Curriculum resource review in reading (preK-5) and math (K-8)
- Implementation of District Strategic Plan of Action
- Monitor attendance at all levels and address concerns through outreach and within statutory requirements
- Focus on the narrowing the gap between non-high need and high-need students
 - Use information from upcoming special education program review
